
I WAS BEING INVITED BY MUHAMMAD HILMAN IDHAM TO CELEBRATE MY BIRTHDAY ON THE 4TH DECEMBER 2020,AT DORSETT HARTAMAS KUALA LUMPUR, PLAZA DAMAS, D-G-8 3, NO.63 JALAN SRI HARTAMAS 1, SRI HARTAMAS, 50480 KL.

OUR FRIENDS ALSO THAT WAS INVITED AND JOINING US THAT NIGHT WERE; ZUL FAHIMIN MAHADZIR (ZUL), NUR FARIHATUL MARDZIAH BINTI MOHAMAD FISOL (MAI) AND RINA SHARINA BINTI ROSLAN (RINA).

8.00 PM: WE HAD OUR DINNER AT RAINTREE SKYBAR & LOUNGE IN DORSETT HARTAMAS.

9.30 PM: RIGHT AFTER DINNER, WE WENT TO A KARAOKE VIP LOUNGE (IN DORSETT HARTAMAS TOO). WE WERE ALL SERVED WITH LIQOUR & CHAMPANGE DRINKS AND SOME PEANUTS FOR BITE. I HAD QUITE AFEW DRINKS (MORE THAN 4 GLASSES),I WAS GETTING TIPSY AND UNABLE TO SING ALONG WITH THE REST. MY MEMORY WAS A BIT VAGUE TO RECALLED THE WHOLE INCIDENT, BUT I FELT LIKE I WAS VOMITTING A LOT. THINGS WERE QUITE BLURRY BUT I FELT HILMAN WAS CARRYING ME WALKING SOMWHERE IN A LONG WALK. THE NEXT THING, I SAW ZULS FACE ON TOP OF ME BUT MY BODY WAS WEAK TO MOVE AND I PASSED OUT.

4.15AM: I WOKE UP AND SAW MYSELF NAKED IN THE HOTEL SUITE ROOM. I STARTED FEELING UNEASY & SUSPECT SOMEONE TOUCHED ME. I LOOKED FOR MY DRESSES AND ITEMS IN THE ROOM. I WENT TO THE TOILET AND SAW A CONDOM WAS IN THE DUSTBIN & IT HAS MADE A CONFIRMATION THAT SOMEONE DID TOUCH AND RAPED ME. I LOOKED AT MY HANDPHONE, RINA & HILMAN DROPPED ME A MESSAGE AT 2.40 AM & 2.37 AM. FROM HILMANS TEXT, HE SAID HE SENT RINAS BACK HOME AND WENT BACK WITH ZUL.



5.00AM -5.30AM: I CHECKED OUT FROM THE SUITE ROOM 619 AND RECONFIRM WITH THE RECEPTIONIST THE PERSONS NAME THAT TOOK THE ROOM, IT WAS UNDER ZULS NAME. I CONTACTED UP MY FRIENDS, OPHIA, KIMI, SUREN & TAN EE LYN ASKING FOR HELP CONSIDERING IT WAS TOUGH TO GET A GRAB AT THE TIME. KIMI CAME BY AND TOOK ME TO MY CONDO, MAISSON ARA DAMANSARA WHILE WAITING FOR TAN EE LYN TO FETCH AND SEND ME TO THE POLICE STATION.

8.30AM: I JUST CALLED RINA TO RECONFIRMED WITH HER ON WHAT HAPPENED LAST NIGHT. SHE TOLD ME, I WAS REALLY DRUNK & VOMITTED A LOT BEFORE I PASSED OUT. SHE ALSO SAID ANOTHER FRIEND OF HILMANS CAME BY QUITE LATE JONING US AT THE KARAOKE VIP LOUNGE, WHO IS ADI IKMAL ISA. RINA SAID SHE LEFT ME WITH MAI IN HOPING SHE COULD TAKE CARE OF ME AT THE HOTEL SUITE.

RINA SAID MAI WAS LAST SEEN TOGETHER WITH ADI AT THE HOTEL SUITE. AFTER HEARING RINAS STORY I AM NOT VERY CERTAIN WHO ACTUALLY RAPED ME, EITHER ADI OR ZUL. IT WAS CERTAINLY NOT HILMAN, BECAUSE I WOULD HAVE KNOWN IT WOULD BE HILMAN AS WE ARE BOTH CURRENTLY GOING OUT TOGETHER.

HEREBY, I HAD BROUGHT SOME ITEMS THAT I FOUND IN THE HOTEL ROOM AS SUPPORTING EVIDENCE TO THE POLICE STATION. I WOULD LIKE TO LODGE A REPORT ON RAPE CASE AGAINST WHOEVER THAT WAS TOUCHING ME BASED ON THE EVIDENCE AND FROM HOSPITAL CHECK UP AS WELL.
